- Mrs. Sims The Board feels compelled to share information in response to a mailing to some taxpayers from LTEA.
- Mr. McLaughlin presented information regarding the information that was sent to taxpayers from LTEA.

- Mr. Lamade stated that he has been on the negotiating team for 22 months. Many residents are on a fixed income and need to deal with the cost of the sewer project. He wants to be fair to everyone.
- Ms. Jill Roman asked if the contract was granted, would they raise taxes. Mr. Lamade replied that would not happen this year.
